**FAMILY**

**BOAT INSURANCE GUARANTEE**

Boats shall carry insurance protection for Third Party and Passenger liability of not less than £3,000,000 in accordance with RYA recommendations. By submitting an application for membership the applicant is deemed to have guaranteed to the Club that any boat owned by the applicant shall be constantly covered by such an insurance policy.
